8 Who is eligible to be a member

- (1) Any person who supports the purposes of the Association is eligible for membership.
- (2) Classes of Membership—
 - (a) **Full membership** is open to honourably discharged members of U.S. armed services and, at the discretion of the Committee, to persons who served the U.S. in wartime.
 - (b) **Affiliate membership** may be offered by the Committee, with approval of the membership, to others who may be Allied service personnel or Allied ex-service personnel or full members of an Allied Ex-Services organization. Affiliate members do not have the right to vote or hold office.
 - (c) **Associate membership** may be offered by the Committee, with approval of the membership, to others who may be widows or widowers of members, adult descendants of members, or others with an interest in promoting the interests of the Association who have not served in the U.S. or Allied armed services. Associate members do not have the right to vote or hold office.
 - (d) **Honorary membership** may be offered by the Committee, with approval of the membership, to non-members who have provided exceptional service to the American Veteran Community or in promoting the purposes of this organization. Honorary members shall not be assessed dues and do not have the right to vote or hold office.
 - (e) **Life membership** may be offered by the Committee, with approval of the membership, to full members who have provided exceptional service to the organization or veteran community. Life members shall not be assessed dues and may vote or hold office.
